NGET shall prepare a draft RESPS Methodology in consultation with owners and operators of Distribution Systems and relevant Transmission Licensees. Following this initial consultation NGET shall publish the RESPS Methodology on the NGET website for a period of 28 days for parties to provide comments to NGET. Evaluation phase to be completed by SPT and SHETL and bought back to February STC meeting. The STC Committee approved for CA031 to proceed to Company Consultation for a period of 10 days. The Final report was submitted to Ofgem on the 18/03/09 and a decision is awaited. CA031 is not being decided on as it is expected to be superseded by a new Amendment Proposal yet to be submitted to the STC Committee. CA031, withdrawn at the 26th January STC Committee meeting. The intention was to submit a new amendment Proposal, CA034 with revised legal text, but as the outcome of the DECC/Ofgem Transmission Access Review has not yet been finalised, CA034 Amendment Proposal has been withdrawn at the February 2010 STC Committee meeting with a view to re-submitting if required at a later date.
