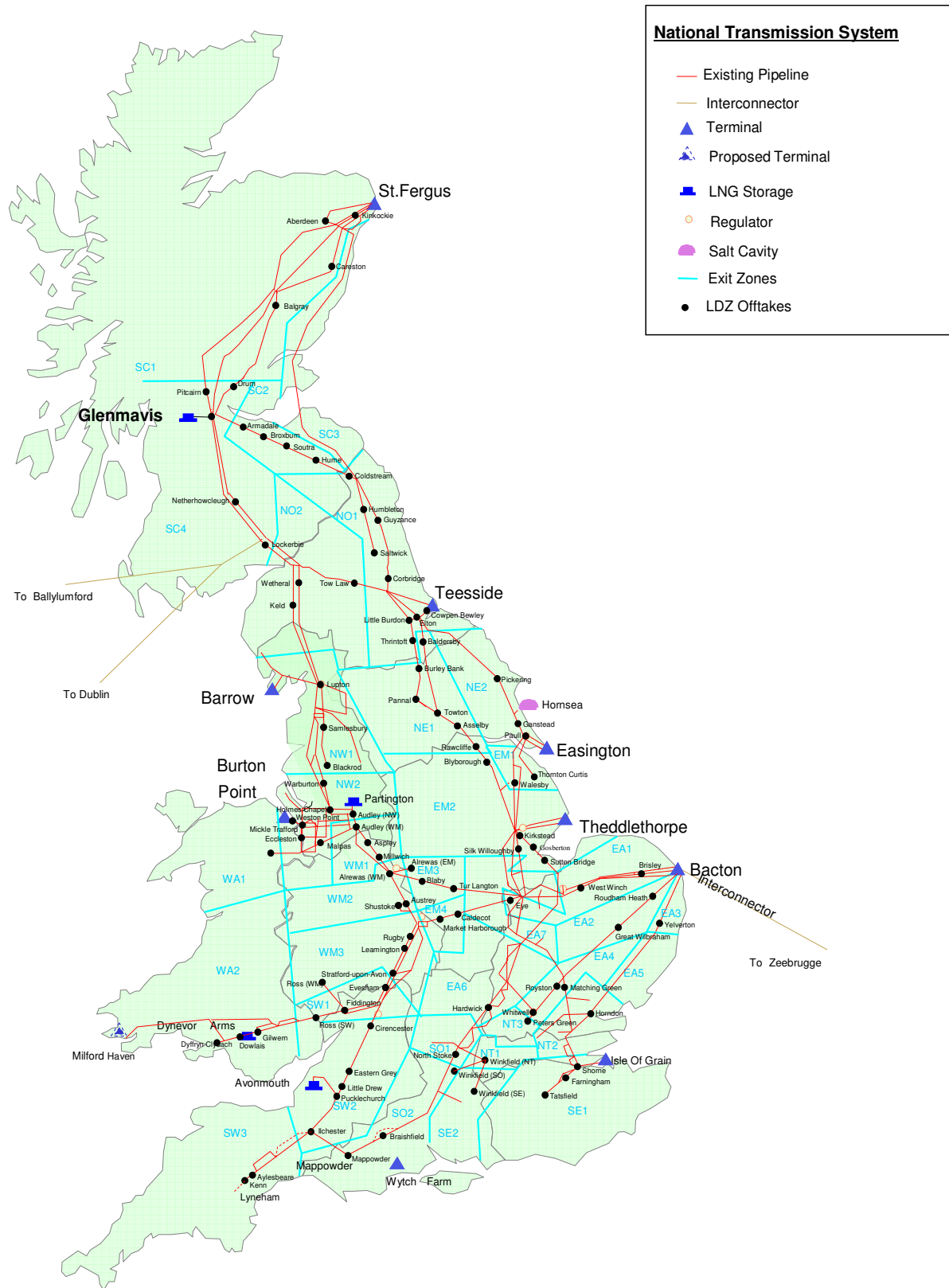

1 Introduction

The content of this publication has been provided in good faith in accordance with Section O paragraph 4.1.2 of the Uniform Network Code following the Notice of Implementation Modification Proposal 0134V "Publication of Nodal NTS Demand Forecasts". The demand and supply data in this notice mirrors the data contained in the latest Transportation model used to set entry and exit capacity prices which will apply from 1st October 2008 and indicative exit capacity prices from 1st October 2009 and 1st October 2010. The supply and demand data is based on data taken from National Grid's current TBE process.

Users may use the data to make more informed decisions about where and to what degree they use the NTS. This is done at their own risk.

This document does not override or vary any of the statutory, licence or Uniform Network Code obligations upon National Grid NTS.

Please do not assume that the data in this publication will remain fixed for a full calendar year.

3 Transportation Model

The Transportation Model has been developed by National Grid to enable transparency of its Gas Charging Methodology in respect of the GB National Transmission System (NTS) and is provided to users on this understanding.

Separate Transportation Models can be provided for each of the 3 years modelled.

Please also note that the model is provided solely for the purpose of estimating capacity charges in respect of the NTS, and is not intended for any other purpose.
