TERMS OF REFERENCE FOR CAP ~~XXX~~ WORKING GROUP

~~Responsibilities~~ **RESPONSIBILITIES**

1. The Working Group is responsible for assisting the CUSC Amendments Panel in the evaluation of CUSC Amendment Proposal CAP~~XXX~~ *[insert full title]* tabled by *[Proposer]* at the Amendments Panel meeting on *[Date]*.
2. The proposal must be evaluated to consider whether it better facilitates achievement of the ~~A~~ applicable CUSC ~~O~~bjectives. These can be summarised as follows:
 - (a) the efficient discharge by the Licensee of the obligations imposed on it by the Act and the Transmission Licence; and
 - (b) facilitating effective competition in the generation and supply of electricity, and (so far as consistent therewith) facilitating such competition in the sale, distribution and purchase of electricity.
3. It should be noted that additional provisions apply where it is proposed to modify the CUSC amendment provisions, and generally reference should be made to the Transmission Licence for the full definition of the term.

SCOPE OF WORK

4. The Working Group must consider the issues raised by the Amendment Proposal and consider if the proposal identified better facilitates achievement of the Applicable CUSC Objectives.
5. In addition to the overriding requirement of paragraph 4, the Working Group shall consider and report on the following specific issues:

6. The Working Group is responsible for the formulation and evaluation of any Working Group Alternative Amendments (WGAAAs) arising from Group discussions which would, as compared with the Amendment Proposal or the current version of the CUSC, better facilitate achieving the ~~A~~ applicable CUSC ~~O~~bjectives in relation to the issue or defect identified.
7. The Working Group should become conversant with the definition of Working Group Alternative Amendments which appears in Section 11 (Interpretation and Definitions) of the CUSC. The definition entitles the Group and/or an individual ~~M~~member of the Working Group to put forward a ~~Working Group Alternative Amendment~~ WGAA if the ~~M~~member(s) genuinely believes the WGAA

- ~~Alternative~~ would better facilitate the achievement of the Applicable CUSC Objectives, as compared with the Amendment Proposal or the current version of the CUSC. The extent of the support for the Amendment Proposal or any ~~Working Group Alternative Amendment WGAA~~ arising from the Working Group's discussions should be clearly described in the final Working Group Report to the CUSC Amendments Panel.
8. ~~There is an obligation on the~~ Working Group ~~M~~members should be mindful of efficiency and to propose the ~~minimum~~ fewest number of ~~Working Group Alternatives~~ WGAAs where possible.
9. All proposed ~~Working Group Alternatives~~ WGAAs should include the ~~P~~proposer(s)'s details within the ~~F~~final Working Group ~~R~~report, for the avoidance of doubt this includes ~~Alternative(s)~~ WGAAs which are proposed by the entire Working Group or subset of members.
10. There is an obligation on the Working Group to undertake a period of Consultation in accordance with CUSC 8.17. The Working Group Consultation period shall be for a period of ~~[#####]~~ as determined by the Amendments Panel.
11. Following the Consultation period the Working Group is required to consider all responses including any WG Consultation Alternative Requests. In undertaking an assessment of any WG Consultation Alternative Request, the Working Group should consider whether it better facilitates the Applicable CUSC Objectives than the current version of the CUSC.

As appropriate, the Working Group will be required to undertake any further analysis and update the ~~O~~original Amendment Proposal and/or ~~Working Group Alternatives~~ WGAAs. All responses including any WG Consultation Alternative Requests shall be included within the final report including a summary of the Working Group's deliberations and conclusions. The report should make it clear where and why the Working Group chairman has exercised his right under the CUSC to progress a WG Consultation Alternative Request or a WGAA against the majority views of Working Group members. It should also be explicitly stated where, under these circumstances, the Working Group chairman is employed by the same organisation who submitted the WG Consultation Alternative Request.

12. The Working Group is to submit ~~its~~ their final report to the ~~CUSC Amendments~~ Panel Secretary on [Date] for circulation to Panel Members. The final report conclusions will be presented to the ~~Amendments~~ CUSC Panel meeting on [Date].

NB: A Working Group must comprise at least 5 mMembers (who may be Panel Members). The roles identified with an asterisk in the table above contribute toward the required quorum, determined in accordance with paragraph 14 below.

14. The cChairman of the Working Group and the Chair of the CUSC Amendments Panel Chairman must agree a number that will be quorum for each Working Group meeting. The agreed figure for CAPXXX is that at least [##] Working Group members must participate in a meeting for quorum to be met.
15. A vote is to take place by all eligible Working Group members on the Amendment P proposal and each Working Group Alternative WGAA. The vote shall be decided by simple majority of those present at the meeting at which the vote takes place (whether in person or by teleconference). The Working Group chairman shall not have a vote, casting or otherwise. as appropriate, as to There may be up to three rounds of voting, as follows:
- Vote 1: –whether each proposal it better facilitates the CUSC Applicable CUSC Objectives;
 - Vote 2: where one or more WGAAs exist, whether each WGAA better facilitates the Applicable CUSC Objectives than the original Amendment Proposal;
 - Vote 3: –and indicate which option is considered the to BEST facilitate achievement of with regard to the CUSC Applicable CUSC Objectives. For the avoidance of doubt, this vote should include the existing CUSC baseline as an option.

The results from the vote [and the reasons for such voting] shall be recorded in the Working Group rReport [in as much detail as practicable].

16. It is expected that Working Group members would only abstain from voting under limited circumstances, for example where a member feels that a proposal has been insufficiently developed. Where a member has such concerns, they should raise these with the Working Group chairman at the earliest possible opportunity and certainly before the Working Group vote takes place. Where abstention occurs, the reason should be recorded in the Working Group report.

- 16-17. Working Group Mmembers or their appointed alternate isare required to attend a minimum of 50% of the Working Group Mmeetings to be eligible to participate in the Working Group vote.

- 17-18. The Technical Secretary shall to keep an Attendance Record, for the Working Group meetings and to circulate the Attendance Record with the Action Notes after each meeting. This will be attached to the Final Working Group Report.

~~18-19.~~ The Working Group membership can be amended from time to time by the CUSC Amendments Panel.

RELATIONSHIP WITH AMENDMENTS PANEL

~~19-20.~~ The Working Group shall seek the views of the Amendments Panel before taking on any significant amount of work. In this event the Working Group ~~c~~Chairman should contact the ~~CUSC-Amendments~~ Panel Secretary.

~~20-21.~~ The Working Group shall seek the Amendments Panel's advice if a significant issue is raised during the Consultation process which would require a second period of Consultation in accordance with 8.17.17 of the CUSC.

~~21-22.~~ Where the Working Group requires instruction, clarification or guidance from the Amendments Panel, particularly in relation to their Scope of Work, the Working Group ~~C~~Chairman should contact the ~~CUSC-Amendments~~ Panel Secretary.

Meetings MEETINGS

~~22-23.~~ The Working Group shall, unless determined otherwise by the Amendments Panel, develop and adopt its own internal working procedures and provide a copy to the Panel Secretary for each of its Amendment Proposals.

REPORTING

~~23-24.~~ The Working Group ~~C~~Chairman shall prepare a final report to the *[Date]* Amendments Panel responding to the matters set out in the Terms of Reference, including all Working Group Consultation Responses and Alternative Requests.

~~24-25.~~ A draft Working Group Report must be circulated to Working Group members with not less than five ~~B~~business ~~D~~ays given for comments, unless all Working Group members agree to three Business Days.

~~25-26.~~ Any unresolved comments within the Working Group must be reflected in the final Working Group Report.

~~26-27.~~ The ~~C~~Chairman (or another member nominated by him) will present the Working Group report to the Amendments Panel as required.
