Proposal in Development

UNC Modification 0214

- Title:
 - Reservation of Firm NTS Exit Capacity at new NTS Exit Points in the transitional period
- Raised by:
 - RWE on 7 May 2008
- Status:
 - Allocated to Transmission Workstream (05 June 2008)
- Next stages:
 - Further Workstream Discussions
 - Report to July or August 2008 Panel

UNC Modification 0214

- Main Features
 - During “Transitional Period” ie up to October 2012
 - Specify the circumstances where an ARCA (Advanced Reservation of Capacity Agreement) would be offered
 - Both for NTS Supply Points where reinforcement is required and not
 - Lays out terms to be included

UNC Modification 0216/A

- Title:
 - 0216 Introduction of an Additional Discretionary Release Mechanism for NTS Entry Capacity
 - 0216A Introduction of Additional Pay-as-Bid Auctions for NTS Entry Capacity
- Raised by:
 - 0216 National Grid NTS on 09 May 2008
 - 0216A E.ON UK on 22 May 2008
- Status: To Panel following close-out
 - (0216) 9/15 Reps supported
 - (0216A) 14/15 Reps supported
 - Preferences – 7 for 0216, 8 for 0216A

UNC Modification 0216

- Main Features
 - Provide further opportunity to release entry capacity
 - At the sole discretion of National Grid NTS.
 - Subject to the application of a Reserve Price. For clarification this will be the prevailing AMSEC auction Reserve Price
 - Applied solely within that Capacity Year

UNC Modification 0216A

- Main Features in addition to 0216
 - All releases will be by pay as bid auction of at least two rounds
 - At least 28 days notice will be given
 - Minimum quantity of at least one month “capacity strip”
 - A sunset clause of 30 September 2009

- Raised by:
 - (0116/V) National Grid NTS 13.09.06/16.11.06
 - (0116A) E.ON 12.10.06
 - (0116B/BV) RWE 13.10.06/16.11.06
 - (0116C/CV/CSV) Centrica 17.10.06/16.11.06/21.12.06
 - (0116VD) Scotia Gas Networks 22.11.06
- Status: With Ofgem for reconsideration
 - Ofgem approved 0116V
 - Competition Commission quashed decision

UNC Modifications 0116 etc

- Main Features
 - Retain Status Quo by deleting sunset clause
 - 0116A
 - Introduce User commitment for flat capacity, retain status quo for flex
 - 0116CVV
 - Introduce User commitment for both flat and flex capacity
 - 0116V, 0116BV, 0116VD

UNC Modifications 0195/AV

- Title:
 - Introduction of Enduring NTS Exit Capacity Arrangements
- Raised by:
 - (0195) RWE (on behalf of Review Group 0166) 17.01.08
 - (0195A) E.ON 21.02.08 (0195AV 17.04.08)
- Status: To Ofgem
 - (0195/1095AV) Unanimously supported by Panel
 - 0195AV preferred by five, 0195 by three
 - Ofgem information request
 - published 18.04.2008
 - close-out 12.05.2008
 - Ofgem impact assessment expected end June/early July

UNC Modifications 0195/AV

- Main Features
 - Both Proposals
 - Introduce User commitment for flat capacity, retain status quo for flex
 - Flex information to be placed on website
 - Staged “ARCA type” commitments
 - Enduring capacity can be booked outside annual windows
 - Less auctions than 0116CVV etc

UNC Modifications 0195/AV

- Main Features

- 0195AV

- Entitlement to Daily Interruptible Capacity up to Maximum Supply Point Offtake Rate
 - Entitlement withdrawn when forecast above 80% peak day
 - Overruns are deemed to be firm bookings with full User commitment.

- Title:
 - Alterations to the RMSEC Auction to Accommodate Transfer and Trade of Capacity Between ASEPs
- Raised by:
 - (0187) National Grid NTS on 12.12.2007
 - (0187A) British Gas on 23.012008
- Status: Ofgem approved 0187A 23.04.2008
 - Implemented 01.06.2008

UNC Modification 0198

- Title:
 - Extension of the Current Sunset Clauses for Registration of Capacity at NTS Exit Points
- Raised by:
 - National Grid NTS 30.01.08
- Status: Implemented 01.06.2008
 - Ofgem approved 01.05.2008

UNC Modification 0198

- Main Features
 - Extend current Exit Capacity arrangements to October 2012
 - This would allow first allocations to take place in July 2009

UNC Modification 0212

- Title:
 - Revision of the Rough Storage Connection Agreement
- Raised by:
 - Centrica Storage Ltd 01.05.2008
 - Urgency agreed by Ofgem
- Status: Implemented 20.05.2008
 - Ofgem approved 19.05.2008

UNC Modification 0212

- Main Features
 - Existing Rough Storage Connection Agreement (SCA) amended to accommodate an increase in the injection offtake rate of the Rough from 21 Million m³/day to 26 Million m³/day
 - No change to UNC
