

Doncaster to benefit from gas mains upgrade

National Grid renewing nearly two kilometres of gas pipes in Doncaster

- **Work will keep gas flowing for the rest of the century**
- **Part of wider investment in Doncaster's gas network**

Friday (1 April) will see the start of a twelve-week engineering project in Doncaster to keep gas flowing to local homes until the end of the century.

National Grid will be renewing nearly two kilometres of new pipes in Moorland Grove, Bawtry Road, Park Lane, Rose Hill Rise and The Avenue. The existing iron mains will be replaced with tough, long-lasting plastic pipes that will last for at least 80 years.

National Grid Authorising Engineer Paul Martin said: "This is vital work that will ensure that local people continue to enjoy a safe and reliable gas supply for decades to come.

"We're sorry for any inconvenience the work may cause. We will make every effort to minimise any disruption and complete the project as soon as possible. We really appreciate people's patience and co-operation."

"We have planned the work to start after the main Easter holiday so that we do not impact on what is a busy family time of year."

To carry out the work safely for all concerned there will be a lane closure on Bawtry Road outside house numbers 27 to 39 during the school half-term holidays between Friday 28 May to Saturday 4 June.

The work is part of a major investment in gas network in the Doncaster area. More than six kilometres of gas pipes are set to be renewed by April.

Gas engineers may need access to homes and businesses to replace service pipes (the pipes that take gas from the main in the road to individual properties). This work will involve briefly interrupting the gas supply and anyone who is affected will be notified beforehand.

All National Grid engineers carry official identity cards, which people should ask to see before allowing them on their property.

Notes to Editors:

National Grid is pivotal to the energy systems in the UK and the north eastern United States. We aim to serve customers well and efficiently, supporting the communities in which we operate and making possible the energy systems of the future.

National Grid in the UK:

- We own and operate the electricity transmission network in England and Wales, with day-to-day responsibility for balancing supply and demand. We also operate, but do not own, the Scottish networks. Our networks comprise approximately 7,200 kilometres (4,474 miles) of overhead line, 1,500 kilometres (932 miles) of underground cable and 342 substations.
- We own and operate the gas National Transmission System in Great Britain, with day-to-day responsibility for balancing supply and demand. Our network comprises approximately 7,660 kilometres (4,760 miles) of high-pressure pipe and 618 above-ground installations.
- As Great Britain's System Operator (SO) we make sure gas and electricity is transported safely and efficiently from where it is produced to where it is consumed. From April 2019, Electricity System Operator (ESO) is a new standalone business within National Grid, legally separate from all other parts of the National Grid Group. This will provide the right environment to deliver a balanced and impartial ESO that can realise real benefits for consumers as we transition to a more decentralised, decarbonised electricity system.
- Other UK activities mainly relate to businesses operating in competitive markets outside of our core regulated businesses; including interconnectors, gas metering activities and a liquefied natural gas (LNG) importation terminal – all of which are now part of National Grid Ventures. National Grid Property is responsible for the management, clean-up and disposal of surplus sites in the UK. Most of these are former gas works.
