## East Midlands National Grid engineers braced for New Year calls

East Midlands engineers on call to deal with gas emergencies 24/7 over the festive period

30 Dec 2014

- **More than 1,448 call-outs across the East Midlands last Christmas and New Year**
- **Stay safe – ring 0800 111 999 if you smell gas**

As party-goers in the East Midlands gear up for their New Year's Eve celebrations, National Grid engineers will be putting the festivities on the back-burner as they prepare to deal with gas emergencies across the region.

National Grid is urging people to ring the National Gas Emergency Service on 0800 111 999 if they smell gas – even on New Year's Eve or New Year's Day.

During the Christmas and New Year period last year, engineers responded to 1,448 emergency calls in the East Midlands (breakdown by area below), with 196 of these on New Year's Eve and New Year's Day. They will be expecting similar numbers this year.

**Nottingham, 187; Leicester, 337; Derby, 259; Mansfield and Chesterfield, 243; Lincoln and Grantham, 163; and Northants, 259.**

The company is reminding people to make a note of the emergency number and not to hesitate to call it if they have a problem with their gas supply or suffer the symptoms of carbon monoxide poisoning - headaches, dizziness, nausea, breathlessness, collapse and loss of consciousness.

Faulty or badly maintained gas appliances can leak deadly carbon monoxide (CO) gas, causing death or serious injury. In a recent inspection in the East Midlands it was estimated that one in 10 of gas boilers, cookers and fires were faulty – and potentially lethal.

Some 40 people a year die of carbon monoxide poisoning and a further 4,000 people seek treatment for symptoms of the deadly gas but National Grid has three simple life-saving tips to keep people safe:

- Ensure gas appliances are installed, maintained and fixed by a Gas Safe registered engineer
- Get your gas appliances checked annually by a Gas Safe registered engineer
- As a backup, buy and install an audible carbon monoxide detector. They can be bought for as little as £15, are simple to install and could save your life

National Grid's emergency call centre at Hinckley, Leicestershire, is on standby to receive tens of thousands of emergency calls from the members of the public across the country over the New Year period. Last year the centre dealt with 337 calls across the Leicester area.

##### **Notes to Editors:**

National Grid is pivotal to the energy systems in the UK and the north eastern United States. We aim to serve customers well and efficiently, supporting the communities in which we operate and making possible the energy systems of the future.

##### **National Grid in the UK:**

- We own and operate the electricity transmission network in England and Wales, with day-to-day responsibility for balancing supply and demand. We also operate, but do not own, the Scottish networks. Our networks comprise approximately 7,200 kilometres (4,474 miles) of overhead line, 1,500 kilometres (932 miles) of underground cable and 342 substations.
- We own and operate the gas National Transmission System in Great Britain, with day-to-day responsibility for balancing supply and demand. Our network comprises approximately 7,660 kilometres (4,760 miles) of high-pressure pipe and 618 above-ground installations.
- As Great Britain's System Operator (SO) we make sure gas and electricity is transported safely and efficiently from where it is produced to where it is consumed. From April 2019, Electricity System Operator (ESO) is a new standalone business within National Grid, legally separate from all other parts of the National Grid Group. This will provide the right environment to deliver a balanced and impartial ESO that can realise real benefits for consumers as we transition to a more decentralised, decarbonised electricity system.
- Other UK activities mainly relate to businesses operating in competitive markets outside of our core regulated businesses; including interconnectors, gas metering activities and a liquefied natural gas (LNG) importation terminal – all of which are now part of National Grid Ventures. National Grid Property is responsible for the management, clean-up and disposal of surplus sites in the UK. Most of these are former gas works.
