Sparking an interest in science: National Grid's electrifying school visit in Tottenham

National Grid delivers educational energy workshop at a Tottenham Primary School

- Pupils learn about past and present means of supplying energy to the area
- National Grid currently dismantling disused gasholders to free up land for future development

Sixty pupils got the lowdown on energy at a special National Grid workshop which explored the subjects of gas and electricity.

National Grid visited Year 6 pupils at Lea Valley Primary School and delivered a session which was designed to help pupils' understanding of energy and encourage an interest in science. Pupils learned about the role of National Grid in supplying the local area's energy, both today and historically.

National Grid is currently carrying out work to dismantle the three gasholders on sites at Willoughby Lane and Leaside Road, in the Northumberland Park area, and pupils were able to learn about how the gasholders were once used to supply energy to the local community.

Experts from National Grid were on hand to help facilitate the session, answer questions and to spark discussion. The team then handed over to education provider, Mad Science, who continued the workshop with the pupils exploring the subject of 'electricity' through a range of materials and exciting interactive demonstrations.

Alison Worgan, Enrichment Co-ordinator at Lea Valley Primary School, said, "It was a fantastic visit and the Year 6 pupils loved learning more about energy and asking the engineers about the work they did. Our thanks go to National Grid for organising such a fun and informative session."

Keith Johnston, National Grid's Land Regeneration Manager, said "We were delighted to visit Lea Valley Primary which is a near neighbour to our site."

"National Grid is always keen to have a positive impact on the communities in which we work and what better way than to get local schoolchildren excited about science."

Councillor John Bevan, representative for Northumberland Park Ward, attended the sessions and said, "It's great to see National Grid's work in the community first hand and that they are giving something back to the local area. The children were genuinely enthused about energy and the engineering taking place on their doorstep with a number asking about careers in the sector".

Work to dismantle the gasholders – which are no longer needed due to technological improvements – began earlier this year and is due to be completed in spring

2015. The project will free up the site for exciting redevelopment opportunities.

National Grid is carrying out similar projects at its former gasworks sites across the country.

Notes to Editors:

National Grid is pivotal to the energy systems in the UK and the north eastern United States. We aim to serve customers well and efficiently, supporting the communities in which we operate and making possible the energy systems of the future.

National Grid in the UK:

- We own and operate the electricity transmission network in England and Wales, with day-to-day responsibility for balancing supply and demand. We also operate, but do not own, the Scottish networks. Our networks comprise approximately 7,200 kilometres (4,474 miles) of overhead line, 1,500

kilometres (932 miles) of underground cable and 342 substations.

- We own and operate the gas National Transmission System in Great Britain, with day-to-day responsibility for balancing supply and demand. Our network comprises approximately 7,660 kilometres (4,760 miles) of high-pressure pipe and 618 above-ground installations.
- As Great Britain's System Operator (SO) we make sure gas and electricity is transported safely and efficiently from where it is produced to where it is consumed. From April 2019, Electricity System Operator (ESO) is a new standalone business within National Grid, legally separate from all other parts of the National Grid Group. This will provide the right environment to deliver a balanced and impartial ESO that can realise real benefits for consumers as we transition to a more decentralised, decarbonised electricity system.
- Other UK activities mainly relate to businesses operating in competitive markets outside of our core regulated businesses; including interconnectors, gas metering activities and a liquefied natural gas (LNG) importation terminal – all of which are now part of National Grid Ventures. National Grid Property is responsible for the management, clean-up and disposal of surplus sites in the UK. Most of these are former gas works.
