

#### What is Ariba Network?




National Grid has implemented Ariba SLP solution, this will provide tools to onboard, qualify, segment and manage Suppliers.

#### **Supplier Value – Cost Implications**



For a Supplier to conduct business with us via our new SAP Ariba SLP, they will need the following:

• A device that can access the internet via a browser (Desktop, Laptop, Tablet or Smart Phone).

Suppliers incur **NO COSTS** to:

- Create their supplier profile.
- Create a new SAP Ariba Network Standard Account.
- Participate in any sourcing event (including Registration and Qualification Questionnaires).

NOTE – There may be a cost for US suppliers to use the Ariba Network for invoicing purposes.

#### **Key Benefits of Ariba SLP**

One of the mutual benefits to using Ariba for Supplier Management is that it allows suppliers to self-maintain their data.


After the supplier registration questionnaire is approved by National Grid, it will re-open for updates. If at any time your company's information changes, you should log into the Ariba Network and update the registration questionnaire to reflect the change.

Keeping the registration questionnaire up to date with accurate details will ensure your company can be considered for other potential business opportunities.

To update your registration questionnaire, log into Ariba, click on the link to open the questionnaire, click "revise response", make the necessary updates, then click "submit".

Changes will be subject to approval from National Grid.




#### **E2E Supplier Onboarding Processes**

National Grid will have three unique end to end processes that the supplier onboarding & registration could follow:

1) Sourcing Supplier Only – this is the process that will be used when the initial request to onboard a supplier is driven by the need to register & qualify a potential supplier to participate in sourcing activities. The supplier will not be asked to provide any trading related information until they have been awarded work through the sourcing process.



2) Purchase Order Only – This is the process that should be followed when the initial request to onboard a supplier is driven by the need to transact with the supplier immediately and will not result in any formal sourcing related activities. This is primarily used for tactical and transactional purposes where NG plans only to issue purchase orders to supplier
