

THE NATIONAL GRID ELECTRICITY TRANSMISSION PLC (SNOWDONIA VISUAL IMPACT PROVISION PROJECT) COMPULSORY PURCHASE ORDER 2020

The Electricity Act 1989 and the Acquisition of Land Act 1981

NATIONAL GRID ELECTRICITY TRANSMISSION Plc (Company Registration Number 02366977) (in this Order called "the acquiring authority"), hereby makes the following Order:

- 1 Subject to the provisions of this Order, the acquiring authority is under Section 10 and Schedule 3 to the Electricity Act 1989 hereby authorised to purchase compulsorily the land and the new rights over land described in paragraph 2 for the purposes of replacing approximately 3.5 kilometres of the existing overhead electricity line and ten pylons which currently span the Dwryd Estuary between Garth near Minffordd in the west and Cilfor in the east with an underground cable tunnel solution and associated tunnel head houses and sealing end compound, together with related works to facilitate delivery of the Snowdonia Visual Impact Provision Project and the subsequent transmission of electricity.
- 2 The land and new rights to be acquired
 - (1) The land to be purchased compulsorily under this Order is described in Table 1 of the Schedule and the land is shown coloured pink and edged red on a map prepared in duplicate, sealed with the common seal of the acquiring authority and marked "Map referred to in The National Grid Electricity Transmission Plc (Snowdonia Visual Impact Provision Project) Compulsory Purchase Order 2020".
 - (2) The new rights to be purchased compulsorily under this Order are described in Table 1 of the Schedule in accordance with the definitions at paragraph 6 below and the land is shown coloured blue on the map prepared in duplicate, sealed with the common seal of the acquiring authority and marked "Map referred to in The National Grid Electricity Transmission Plc (Snowdonia Visual Impact Provision Project) Compulsory Purchase Order 2020".
- 3 Parts 2 and 3 of Schedule 2 of the Acquisition of Land Act 1981 are hereby incorporated with this Order and references in the said Parts 2 and 3 to "the undertaking" shall be construed as including the works to be constructed by the acquiring authority in, on, over and under the land subject to this Order.

4 As from the date on which this Order becomes operative or the date on which any new right is vested in the acquiring authority, whichever is the later, the land over which the new right is acquired shall be discharged from all rights, trusts and incidents to which it was previously subject so far as their continuance would be inconsistent with the exercise of that new right.

5 Where in this Order a new right is acquired it shall be exercisable at all times by the acquiring authority, its successors in title, lessees, licensees, assigns and those deriving title from them and all persons authorised by any of these.

6 (1) In Table 1 of the Schedule to this Order, the following terms shall have the following meaning:

(2) The land shown coloured blue is a two-dimensional representation of a three-dimensional rights corridor within which will be located the tunnel, cables and associated works together with the "Development Exclusion Zone" with an overall maximum vertical dimension of 18 metres (22 metres at Garth) and an overall maximum lateral dimension of 12 metres (16 metres at Garth). The plot description refers to plot areas in square metres as the two-dimensional representation. The rights corridor may deviate laterally as shown on the Map to this Order and vertically as described.
